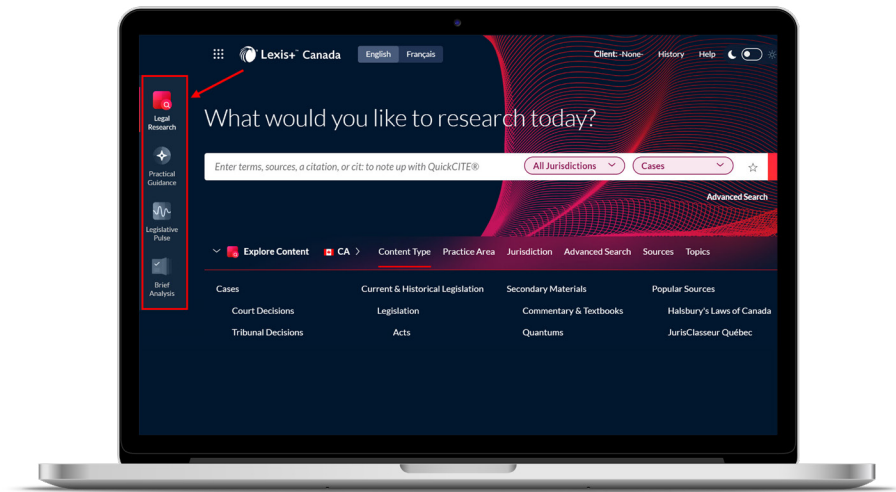

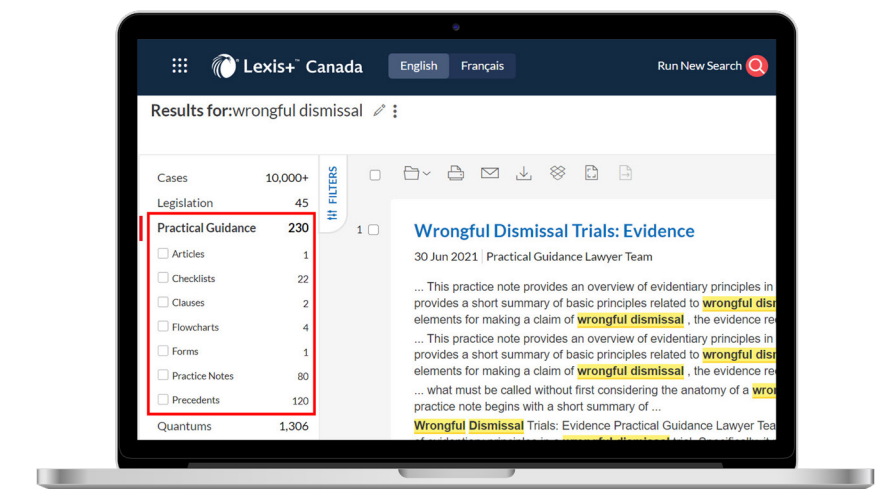

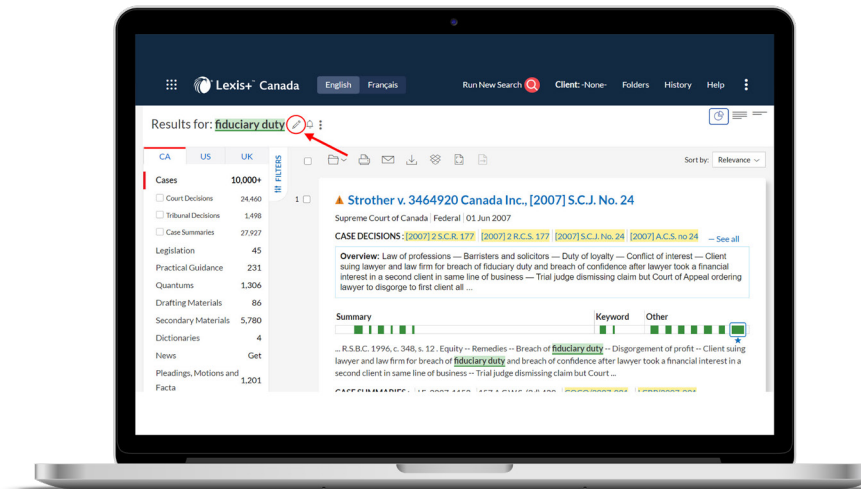

Simply enter your search terms into the search box and select **Practical Guidance** on the content type list on the results page.



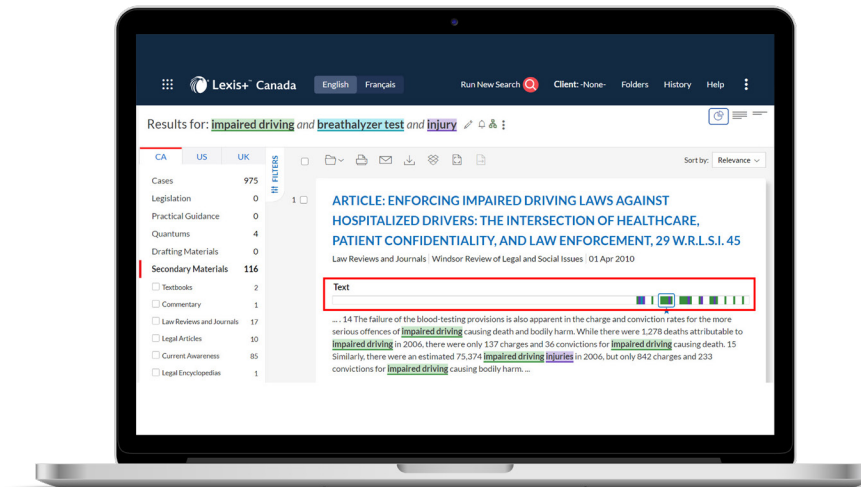
EDIT YOUR SEARCH

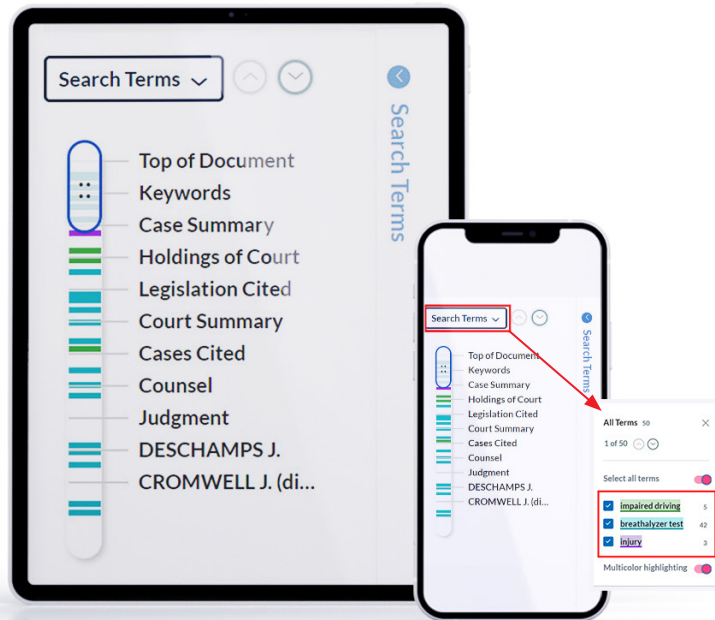


SEARCH TERM MAPS NOW AVAILABLE ON OTHER CONTENT TYPES

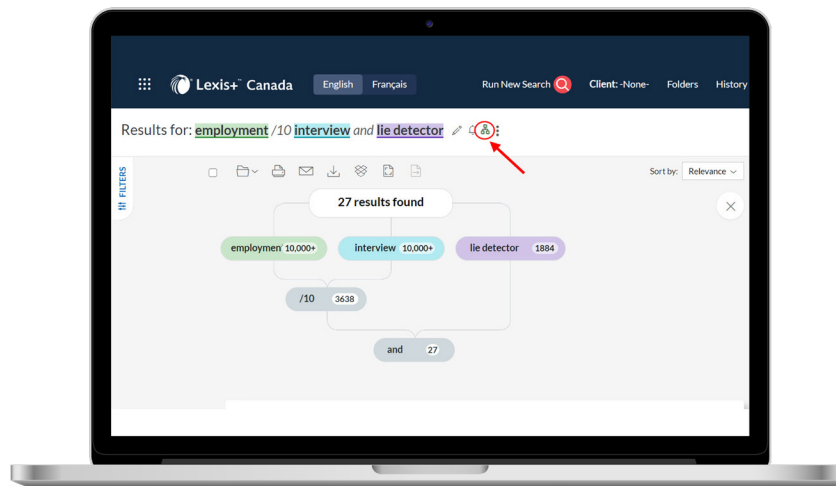

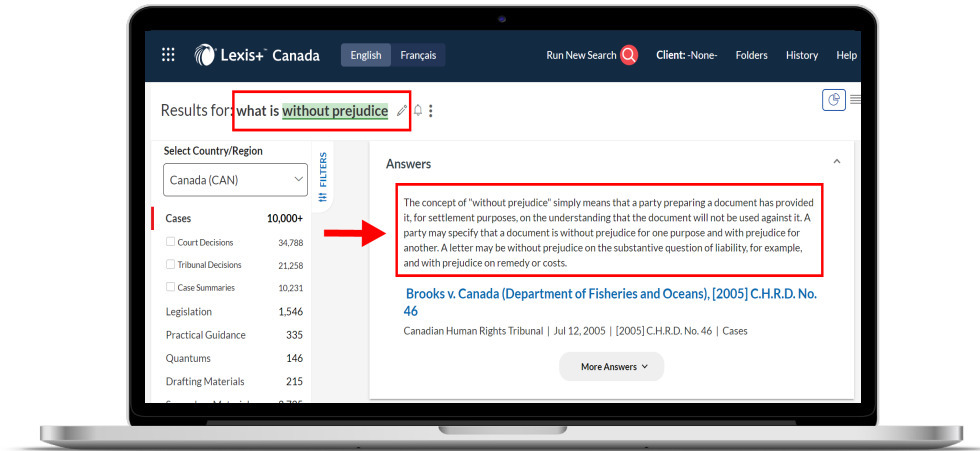
BOOLEAN SEARCH TREE
